### Matthew Crawford Architects SYC 20 Yr. Master Plan Presentation

DBCA has moved to reclaim 20m greenspace back from the Club commencing from the high-water line. For an extended water lease area the Club must surrender the greenspace.

Matthew talked through the proposed eight (8) stages for the Club transformation over the next 20 years.

Questions from Members:

Steve Brew 13097 - Stage 1 showed rebuilding of jetty 5 to be a different stage to Stage 2. Matt Crawford confirmed this was an oversight given the late changes recently by DBCA and that it would be corrected.

Steve Brew 13097 – In regard to the DBCA action to reclaim green space, has the club been targeted? Matt Crawford responded that other clubs along the river have faced similar circumstances.

David Harris 11256 – Are we losing the overflow car park? Is the assumption we will no longer need the overflow parking? Matt Crawford advised green belt does extend over the area. Steve Browne advised the Committee is still trying to negotiate to keep the management of the overflow car park, by working with ToEF.

Tim Howard 5203 – Is Aquarama being forced to lose the 20m of their stacking facility? This issue has been raised due to the requirement of the SYC to expand the development. It has been advised that all future developments/redevelopments will also have the 20m green space requirement applied to them.

Tim Howard 5203 - Are we going to lose more parking with additional members and boats? Steve Browne explained the extension of jetty does not necessarily mean large increase in member's numbers but more of a rationalisation improvement of processes such as wave attenuation and safe turning of corners.

Rodney Drown 12677 – What is green space? Matt Crawford advised this was non-descriptive but is determined to be an area with no buildings on it.

Caroline Stewart 14675 – What is the net gain to water lease? What is the increased number of wet pens? What is the increased capacity of the dry stack? Mark Maczkowiak responded that due to new Australian Standards the club is required to change the turning space behind the boats. Dry stacking has the advantage of being created in a modular format so it can be built in stages. No trailer boat parking would be lost.

Jamie Penn 14061 – Is there any averaging allowed of the set back? Matthew Crawford responded that this was asked but was non-negotiable.

DBCA has accepted in principle the application for Jetty 5. Overflow car parking negotiations have not yet been finalised. Jetty 5 application will be lodged in the coming weeks, and we have been advised approval will take between 6 - 12 months.

### **Commodore's Slipway Presentation**

Perry Holland 14806 – SFM are they going to let us work on our boats? Members were advised to read SFM's terms and conditions upon booking.

Perry Holland 14806 - Recommended the quickest option possible.

John Edwards 1497 – What work will members be allowed to do, high pressure and scrape downs? Club employee will be responsible for this in a purpose-built area.

John Edwards 1497 – Requested for the presentation to be emailed to members. It was advised that a link will be provided on the SYC website.

Caroline Stewart 14675 – Questioned the impact of the dry stacker on the Clubrooms and the impact of the restricted morning sunlight? Matthew Crawford advised the stackers have been placed far enough away to not impact the club.

Rodney Drown 12677– In regard to options two and three, does that include how we use it on a multi hull boat? Steve Browne to investigate further.

Martyn Potter 13764 – Are we at risk of becoming a "Blue HQ" with a clubhouse in the middle? Steve Browne advised we are mindful of the appearance and functionality.

Martyn Potter 13764 - Is option one even viable? Steve Browne responded that it seems the amount of land that will be lost may not make option one viable.

Garry Barker 1093 – Does option two handle keel boats? Steve Browne Yes.

Garry Barker 1093 - With a stacker arrangement what length boats would use it? Steve Browne stated 12m boats would be the absolute max but would also be dependent on weight.

Ian Grosse 14922 – Option two and three will they be interacting with the normal card and trailers? Steve Browne advised they will be interacting with the boat ramp traffic.

Ian Grosse 14922 - Option three, will there be a boat ramp with a negative wharf? Steve Browne acknowledged there will be a new boat ramp that runs parallel with the negative wharf.

Jeremy Telfer 7007 – Option three requires a large amount of area to float the boats on a jetty during peaks. Is there enough room? Steve Browne advised there would be a floating jetty which will be extended and both sides would be available for use.

Jetty 5 report was lodged a few weeks ago. DBCA looks to have agreed in principle, allowing us to increase our water lease.

Sand Bars and pile testing occurred in recent weeks.

Natalie Jones has been appointed as the new Marina Manager. Natalie will be responsible for the availability and suitability of pen allocations. Natalie will be the first point of contact for all things marinas.

Incident Reports can now be lodged on the Club website.

Where breakages have been recorded, items will now be tagged to highlight the report has been made.

Compliance checks are now completed.

Snubbers need to be installed in all pens before the end of September. Natalie or Mark will help on the process of changing out the snubbers if required.

All D shackles must be moused.

### 6. General Business

Perry Holland 14806 – River deck re-opening was great. However unruly kids are ruining the place. Steve Browne advised short term plan for accessing the river deck is changing which is hoped to stop the kids from playing on it. A new access point is also being planned and will be gated.

Steve Brew 13097– Jetty 5 points for clarification:

- Availability of 17m pens Mark Maczkowiak advised we may be able to offer pens up to 23m in length.
- 17m pens appear to be in short supply Mark Maczkowiak advised that the extension of the water lease allows bigger pens whilst meeting the Australian standard.
- Positioning of the pens Mark Maczkowiak advised this has not yet been progressed as the Mooring Committee were awaiting approval.

Jamie Penn 14061 – Are there any plans for the dredging of sandbar? Steve Browne advised that in the short term there is no plan for dredging whilst Jetty 5 is progressing.

Jamie Penn 14061 – will there be a rationalisation of the new pens? Steve Browne Yes.

Martyn Potter 13764 – Requested a speed camera for the corner of the jetty. Mark Maczkowiak has previously put forward this request, but this is not currently available.
